Dear Minister

Including progress on aid transparency within Korea's Open Government Partnership Action Plan.

We the undersigned civil society organisations are writing to congratulate the Korean Government on its leadership in development effectiveness around the Fourth High Level Forum on Aid Effectiveness (HLF-4).ⁱ As Korea prepares its Open Government Partnership (OGP) Action Plan for April 2012, we encourage you to use this opportunity to build on the aid transparency commitments made at HLF-4.

As you will be aware, the International Aid Transparency Initiative (IATI)ⁱⁱ provides an essential common standard and open format for aid information, to which all donors committed at HLF-4. For this reason and in order to maintain the leadership Korea established and demonstrated in Busan, it would be most fitting to initiate Korea's engagement with IATI at this time and to include action points relating to the IATI process within Korea's OGP Action Plan.

Korea's vision - *to satisfy the people's expectation, build public trust in government and foster government efficiency, effectiveness and responsiveness* - outlined within Korea's January 2012 OGP Country Updateⁱⁱⁱ, can be appropriately applied to aid transparency. We therefore anticipate seeing more specific action points relating to aid transparency included within Korea's OGP Action Plan itself.

Through the commitments already delivered by OGP founding members, including the UK and U.S., the links between the OGP and IATI agenda's have been made explicit^{iv} as has the potential for OGP participation to complement the IATI process and vice versa. Thus it might be appropriate to include the following intentions within Korea's OGP Action Plan:

- Signing up to IATI and engaging with the initiative at a political and technical level;^v
- Submitting Korea's IATI Implementation Schedule by December 2012;
- Beginning to publish Korea's aid information to the IATI Registry in 2013;
- Implementing IATI fully by December 2015.

We look forward to working with you and your officials in the future as Korea continues to make progress in this important area.

We will agree on this standard and publish our respective schedules to implement it by December 2012, with the aim of implementing it fully by December 2015.'
