#### **Overview**

The Department of Defense (DOD) works to encourage and enable international partners to work with the United States to achieve strategic objectives, a number of which are foreign assistancerelated in approach, whereby Congress has authorised DOD to train, equip, and support foreign defense and security establishments under a discrete set of circumstances.

#### Achievements and progress

- After sliding in the last three assessments, DOD is now in the 'fair' category for the first time having made an improvement of 16% relative to the 2014 Index.
- Since the 2015 U.S. Aid Transparency Review, Defense has published nine new fields at the activity-level to the IATI Registry (actual dates; aid type; collaboration type; commitments; disbursements and expenditure; finance type; flow type; implementer; tied aid status) and three new fields at the organisational level (annual report; audit; procurement policy).

#### **Challenges and room for improvement**

- DOD does not publish a complete organisation file to the IATI Registry. An organisation strategy and an allocation policy are always published but not to the IATI Registry.
- Fourteen activity-level indicators are not published to the IATI Registry. Planned dates and titles, previously published to the IATI Registry, are no longer available in that format. Eight indicators are not published at all including sub-national locations, Memoranda of Understanding, evaluations, activity budgets, budget identifiers and all activity performance indicators.
- For all U.S. agencies, aid data is published only quarterly to the IATI Registry.

#### **Recommendations**

- DOD should aim for full implementation of the IATI Standard prioritising a complete organisation file with disaggregated budgets.
- It should then work to improve the depth and breadth of its activity level publication to the IATI Registry paying specific attention to activity-related documents, financial and performance information.
- DOD should publish timely data to the IATI Registry throughout the year.
