4. Finance

- SG: Reported back from Finance Committee
- Budget versus Actual: Core & projects expenditure within budget. Reserves forecast to decline from three months to two months by end of financial year (September 2017)
- Cash Flow: Year-end cash flow position is adequate, with some carry-over to the next year
- Match Funding for JUDS, Board agreed to assigned Core Staff time (SR & LG), noting that the promised grant from IDRC has been delayed
- Agreed to add another bank account for reserves
- SG signed audited accounts

5. Advocacy Strategy

CT Outlined new advocacy strategy with four objectives from now to 2018:

- Donor commitments to transparency in aid and development are strengthened
- Visibility of data on aid and development finance in partner countries is improved
- Quality of data that donors publish on aid and development finance is improved
- Data is used to improve aid and development effectiveness and accountability

The strategy also includes scoping on transparency of humanitarian aid, development finance institutions and UK aid.

GB: Offered feedback from Board and concerns about strategy too ambitious, is it realistic?

CT: Strategy formalises what PWYF already does, challenging but achievable. Regular reviews in place.

GB: Summarised discussion: General agreement this is a sensible interim approach until 2018

ED: Updated the Board on status of the methodology review, which is due to conclude in the coming months

ED: Gave a report on data use scoping visit to Benin and Tanzania

ED: Talked through findings from IATI Technical Advisory Group (4 staff attended)
