The reasons for negative responses were identified as a combination of budget constraints, a decision not to desimal grants and technical issues specific to individual organisations which would make submission in 2026 impractical.                                                           |  |

The formal deadline remains the 30 <sup>th</sup> September 2025, but those organisations still considering would continue to be chased, with a deadline for payment of the end of November. |  |

- PWYF would have clear ethical standards in terms of which organisations could be included and how conflicts of interest would be managed.
- It was recognised that the timing was challenging, particularly for the UN agencies who are facing significant cuts.

### **Additional Projects**

GF advised that two new projects have been secured, which will be delivered by existing staff:

- A contract with CAF potentially worth \$150,000 per year, potentially running for two years.
- A contract with CABEI potentially worth \$75,000 per year, with two years paid upfront. Potentially running for three years.

In response to questions from the Trustees, it was noted that:

- The projects would start after the decision-point was reached. CAF is due to start in December and CABEI would start in January 26.
- The value of the transparency project and DFI Index as global vehicles, allowing PWYF
  to be included in global conversations was noted. There was concern that without these
  vehicles, PWYF would not be considered for future projects of this type. GF confirmed
  that the DFI project continues until early 2027.
- It was agreed that in response to questions from interested clients, PWYF should revisit how major players who did not join the index could be included. **ACTION** AT and GF to review the options for inclusion of non-paying significant organisations in the index.

#### **Project Update**

The PWYF team provided the following updates on key projects:

- The Girls not Brides project is being concluded.
- The UK aid transparency review is due to be published with the FCDO. There are 9
  official development assistance (ODA) spending departments included. The findings will
  note that the Home Office have ceased publication and the FCDO are aware of this
  inclusion.

#### Staffing update

GF noted Sally Paxton's departure. He noted that she administered Friends of Publish What You Fund and he would be meeting with them to discuss next steps.

#### 4. Finance

JH presented the finance paper and highlighted the following key points:

- The cashflow is based on a pessimistic estimate of 15 participants in the index.
- The budget is prudent
- The cashflow is tight but does not require any redundancies and therefore would not trigger the enhanced redundancy plan.
- In the worst-case scenario, where insufficient participants were secured for the index to be viable, the agreement with CIFF and Gates to incorporate DFI related redundancy costs in their funding has a positive impact on reserves and close-down date.



GF noted that they are reviewing how staff costs are allocated to projects and how core costs are covered.

The following points were raised by Trustees:

- Clarity was sought that changing the funding model does not impact the Charity status. It
  was confirmed that PWYF would continue to act in line with its charitable purpose.
- MJ asked how the changing budget would be reviewed by the Trustees. JH confirmed it would be presented for challenge every quarter.

GF reflected on the process that would be gone through with the auditors to confirm that PWYF is a going concern.

The Trustees approved the annual payment to Friends of Publish What You Fund of £15,000

The Trustees **approved** the budget.

#### 5. Any Other Business

VJ advised the meeting that she had responded to all requests for updates from the Charity Commission in relation to the previously submitted Serious Incident report. Unless there were further significant changes the Charity Commission now wish to be updated by January 2026.

MJ asked what the current situation with IATI was and whether there were opportunities or challenges for PWYF. GF provided a brief overview, although nothing concrete is known at this time. MJ noted the need to think about who is leading the conversation on aid transparency.

GF advised that due to the need for prudence there would be no Christmas meal

GF thanked JH, AK, KO and MJ for their significant recent contribution.
